

ORDINANCE 174 3RD SERIES

AN ORDINANCE OF THE CITY OF WADENA, MINNESOTA AMENDING THE WADENA CITY CODE, BY REPEALING SUBDIVISION 5, SUBSECTION A, B, AND C OF SECTION 6.32 OF CHAPTER 6, ENTITLED MASSEUR AND MASSEUSE LICENSE AND ALSO REPEALING SUBDIVISION 5 E, SECTION 6.31, CHAPTER 6, ENTITLED SAUNA PARLOR AND MASSAGE PARLOR RESTIRCTION AND REGULATIONS AND THEN ADDING SUBSECTION 5 A, B, C, D, AND E TO SECTION 6.32, CHAPTER 6

THE CITY COUNCIL OF THE CITY OF WADENA ORDAINS:

SUBDIVISION 5- A, B, & C, OF SECTION 6.32 ENTITLED RESTRICTIONS AND REGULATIONS IS HEREBY REPEALED

- A. Whenever a massage is given it shall be required by the masseur or masseuse that the person who is receiving the massage shall have his buttocks, anus, and genitals covered with an appropriate non-transparent covering.
- B. Any masseur performing any massage shall at all times have his anus, buttocks and genitals covered with a non-transparent material.
- C. Any masseuse performing massage shall at all times have her breasts, buttocks, anus, and genitals covered with a non-transparent material.

SUBDIVISION 5- E, SECTION 6.31, CHAPTER 6 ENTITLED SAUNA PARLOR AND MASSAGE PARLOR, RESTRICTIONS AND REGULATIONS IS HEREBY REPEALED

- E. Only masseurs shall be allowed to massage male customers and only masseuses shall be allowed to massage female customers.

SUBDIVISION 5- A, B, C, D, & E OF SECTION 6.32 ARE HEREBY ADDED TO READ:

- A. The licensee shall carry, and display upon request his/her license while working within the City.
- B. No licensee shall perform or offer to perform massage services within the City while under suspension or revocation by City Council.
- C. No person shall solicit business in any public place or in any licensed liquor establishment within the City.


D. No person shall practice massage for compensation in a location other than a massage parlor licensed pursuant to Section 6.31 hereof, except that such services may be provided:

1. In a private home for legitimate home-health care needs;
2. At special events for which a temporary permit has been issued by the City. The provisions of Section 6.31, Subd. 5 hereof shall be considered in determining the issuance of any such temporary permit.

E. A massage parlor which is an "adult massage parlor" as defined by Section 6:33, Subd. 4 A. 10. shall be governed by and subject to the provisions of Section 6:33 of this ordinance governing sexually oriented businesses.
